



On behalf of the Commission on Collegiate Nursing Education (CCNE), I am pleased to advise you that the CCNE Board of Commissioners acted at its meeting on October 19-22, 2015, to grant accreditation to the baccalaureate degree program in nursing at Farmingdale State College for 5 years, extending to December 31, 2020. The accreditation action is effective as of February 18, 2015, which is the first day of the program's recent CCNE on-site evaluation. You should plan for the next on-site evaluation to take place in the spring of 2020.


At its meeting, the Board determined that the program met all four accreditation standards. The Board additionally determined that there are no compliance concerns with respect to the key elements.

A copy of the accreditation team report that was sent to you earlier, along with the program's response to it, is being transmitted to the institution's chief executive officer as the Commission's official report to Farmingdale State College. We hope that both the results of the self-study process and the team report will be useful to the continued growth and development of the nursing program. A certificate of accreditation is enclosed.

in accordance with CCNE policy, if a program or institution elects to make a public disclosure of a program's accreditation status with CCNE, the program or institution must disclose that status accurately. The program or institution disclosing the information must identify the nursing program and its affiliation with CCNE. This statement must include either the accrediting agency's full name, address, and telephone number or the accrediting agency's full name and address of the website home page, which identifies CCNE's address and telephone number. For more information on CCNE's disclosure policy and to access the statements that CCNE has approved for use, as well as information on use of the CCNE accreditation seal, please visit http://www.aacn.nche.edu/ccne-accreditation/seal-policy/baccalaureate-graduate. Please ensure that the institution's website and other materials are updated to reflect this language, as appropriate.

As is required for all accredited programs, a Continuous Improvement Progress Report (CIRR) must be submitted at the mid-point of the accreditation term. Please note that the GIRR needs to address and demonstrate the program's compliance with the CCNE standards and key elements that are in effect at the time of its submission. As a courtesy, CCNE will send a reminder letter to the chief nurse administrator approximately five months prior to the CIPR submission deadline, informing the program of the specific standards to be used and providing guidance for the preparation of the reports. The deadline for submitting the CIPR to CCNE is June 1, 2018. The Report Review Committee, and then the Board of Commissioners, will review the CIPR. For more information about CIPRs and the report review process, please refer to the CCNE procedures.





As a reminder, programs are expected to continue to comply with the current CCNE standards and procedures throughout the period of accreditation. These documents are available at http://www.aacn.nche.edu/ccne-accreditation/standards-procedures-resources/baccalaureate-graduate. This includes advising CCNE in the event of a substantive change affecting the nursing program. Substantive change notifications must be submitted to CCNE no earlier than 90 days prior to implementation or occurrence of the change, but no later than 90 days after implementation or occurrence of the change. These reporting requirements are discussed further in the CCNE procedures.

Thank you for your participation in the CCNE accreditation process and your commitment to quality nursing education. The Commissioners join me in expressing our very best wishes as you continue to promote excellence in nursing education.

Dear Dr. Goodstone,

On October 7, 2020, you were notified that the CCNE Board of Commissioners acted to adjust the accreditation expiration date of your baccalaureate degree program in nursing that was originally scheduled to host a CCNE accreditation evaluation in Spring 2020. That evaluation was postponed by CCNE due to the COVID-19 pandemic. This correspondence confirms that the expiration date of the accreditation term of your institution's baccalaureate degree program in nursing was adjusted by the CCNE Board of Commissioners at its September 22-25, 2020 meeting. Specifically, the Board adjusted the expiration date of December 31, 2020 so that it is now December 31, 2021. Such action is intended to help protect students enrolled in the program in light of the fact that the CCNE evaluation was postponed from Spring 2020 to Spring 2021 as a result of the COVID-19 pandemic. The Board's decision-making meeting regarding the program's accreditation evaluation will be held in Fall 2021, prior to the adjusted accreditation term expiration date.

CCNE will ensure that its records and website listing of accredited programs are updated to reflect this adjustment. CCNE invites you to share this information with any constituents or stakeholders who may have an immediate need for this information (e.g., students applying for internships, scholarships, or financial assistance).
