# Student ID and Parking Permit

- To obtain a student ID card, bring a copy of your academic schedule or paid tuition bill to University Police. Resident students can get a student ID card one week prior to move-in day. Commuter students can get their ID card during the first week of classes.
- Students that will be driving to campus need to purchase a parking pass for their vehicle. Purchase a parking permit at [University Police](#).

# For Students Living on Campus

- **Residence Hall Move-In starts on Thursday August 22, 2024**
- If you need on-campus housing complete the Housing Application on your RAM portal.
- To move into the Residence Halls, you must be registered for classes and have a paid tuition bill. If you do not have a schedule or your tuition bill is unpaid, you may lose your room assignment and be placed on a waiting list.
- Students living on campus must also be medically cleared by the Health and Wellness Center. To verify that you are medically cleared email the Health and Wellness Center at [wellness@farmingdale.edu](mailto:wellness@farmingdale.edu) prior to the move in date.

## Climate and Clothing

- On Long Island you will experience 4 seasons. Long Island has warm, humid summers and cold winters. Clothing made from light cotton is most comfortable for the summer. In the fall and spring, add heavier cotton and light woolens. Boots and winter coats will be needed for the colder months.



# International Student Health Insurance

- International Students are required to enroll in the SUNY approved Health Insurance Program.
- You will be automatically enrolled in health insurance each semester. The enrollment cost is added to your tuition bill.
- After enrollment, you will receive an email from United Health Care. This email will include coverage details, instructions on how to set up your account, how to access your membership ID card, and find health care providers. If you do not receive an email from United Health Care by the first day of classes contact the International Office.

- Before departing for the U.S. you may want to schedule a routine check up with your healthcare provider, eye doctor and dentist. Don't forget to pack your prescriptions and prescription medication. Special restrictions may exist for traveling with medication. See the [Transportation Security Administration](#) (TSA) website for information on traveling with prescription medications.

# Traveling to the U.S.

- Students issued an Initial I-20 or DS-2019 are allowed to enter the U.S. up to 30 days before the program start date printed on their I-20 or DS-2019. This is the earliest date you are allowed to enter the U.S.
- When you arrive at the port of entry, Customs and Border Patrol will ask to see your immigration documents. Carry the following documents with you in your carry-on bag, NOT in your checked bags:
  - Valid Passport With Your F-1 or J-1 Visa
  - I-20 or DS-2019 Form
  - Supporting documentation that you showed to the U.S. Embassy to obtain your visa. (Evidence of financial resources, admissions letter, receipt of the SEVIS fee payment)
- If the Customs and Border Patrol officer at the port of entry cannot verify your information or you do not have all the required documentation, you may be directed to an interview area known as “secondary inspection.”
- If you encounter difficulties at the port of entry and need assistance, contact the International Office, call 1.934.420.2479 during regular office hours (Monday-Friday 9am to 4pm EST). If you need to reach the college outside these times contact Farmingdale State College University Police at 1.934.420.2111.
- We suggest bringing about \$100 U.S. dollars with you in cash to pay for small expenses that can occur after your arrival.

# Traveling to Farmingdale State College

- Farmingdale State College is approximately 25 miles from JFK International Airport. Ample transportation is available from JFK International Airport. Visit the [transportation webpage](#) for a list of transportation providers that are permitted to serve JFK International Airport.
- If you plan to book a taxi or shuttle, you can reserve your airport transportation BEFORE you leave your home country to ensure that your chosen transportation method will be available upon arrival.

# Deferral or Cancellation

- If you are unable to arrive by the Program Start Date on your I-20 (for F-1 visa students) or DS-2019 (for J-1 visa students), contact the International Office immediately.
- A late arrival can jeopardize your entry to the U.S. Do not attempt to arrive to the U.S. after your program start date.

# F1 and J1 Student Orientation

**All initial (new), transfer and change of status students are required to attend International Student Orientation.** Orientation is hosted by the Office of International Education and Programs. During orientation you will check in with the International Student Advisor, learn about important immigration responsibilities as well as important aspects of your program and the resources available at the college.
